- 1991 ~ NEK-CAP, Inc. was expanded to include Jefferson, Marshall, and Pottawatomie Counties
- 1992 ~ Head Start Family Services Demonstration Project was funded
- 1992 ~ The Section 8 Family Self-Sufficiency (FSS) grant began
- I994 ~ NEK-CAP, Inc. purchased and renovated nine older homes for affordable rental property for income eligible tenants
- 1997 ~ Construction began for Jefferson Village apartments located in Winchester, Kansas
- 1997 ~ The TBRA program began
- 1997 ~ Received Early Head Start federal and state funding
- 2000 ~ NEK-CAP, Inc. was expanded to Riley County

- 2000 ~ The Annie L. Johnson Child and Development Center opened in August, in Holton, Kansas.
