FAMILY & COMMUNITY RESOURCES

The Family and Community Resources program supports all families eligible for our programs in NEK-CAP, Inc.'s sixteen county service area. Every family deserves support and encouragement as they begin developing their family, no matter the stage of development. NEK-CAP, Inc.'s "integrated services" approach gives everyone an opportunity to have their immediate needs met and continue to be supported with NEK-CAP, Inc. programs and services as the family develops and moves to self-sufficiency.

FILLING THE GAP



NEK-CAP, Inc., and Kansas Food Bank collaborate to offer Filling the Gap, a youth summer food program, for eligible youth (to age

18) during the summer when school is out. With the help of local health departments and hunger advocates, we are able to Fill the Gap and provide missing summer meals to at risk of children going hungry. Approximately 100 youth are served through this program offered in the six Northcentral counties of Jewell, Mitchell, Osborne, Republic, Smith and Washington.

Filling the Gap provides free shelf-stable, pre-packaged meals to eligible youth each week that are participating in the program. This program was created to ensure that lowincome youth continue to receive balanced and nutritious meals while school is not in session. Summer is a time when children who rely on free and reduced meals at school struggle the most. Meals that they depend daily are not available upon them. Currently one in five children in our state faces hunger on a daily basis.

LOVE AND LOGIC



Love and Logic® provides simple solutions and easy to use techniques to help parents have more fun and less stress while raising responsible kids of all

ages: raise responsible kids; have more fun in their role; and easily and immediately (first use) change their children's behavior.

TACKLING THE TOUGH SKILLS



Tackling the Tough Skills[™] is a fun, innovative and highly interactive life skills curriculum that helps hard-to-reach adults or teens prepare for success in

work and life. It's also being used to teach soft skills to employees in the workplace. Soft skills aren't "fluff." They are life skills many take for granted, yet are critical when a person doesn't have them. Soft skills include responsibility, attitude, communication. problem solving and preparing for the workplace.

REALL SIMULATION



What is the REALL project? The Reality Enrichment And Lessons (REALL) project is a handson simulation designed challenge youth (grades 7th - 12th)

to think critically about how choices and decisions made in adolescence may have consequences in adulthood. The simulation is divided into interactive sessions (Reactive Life and Proactive Life) which educate youth on the consequences of their choices. During both reactive and proactive sessions.

adult level participants must meet responsibilities, such as going to work, budgeting, paying bills and caring for children.

POVERTY SIMULATION



The Community Action Poverty Simulation (CAPS)* is a unique tool that can be used educate to

everyone, from policy makers to local community leaders, about the typical day to day strategies of a low-income family trying to survive, day to day, with a shortage of money and an abundance of stress. It is a simulation, not a game. The object is to sensitize participants to the hardships faced by real people. In post-experience surveys, over 85% of participants reported an above average or high level of increased knowledge about the financial pressures faced by lowincome families in meeting basic needs.
