# Head Start Works!!

Atchison Head Start has a family who entered our program in 2011 with their twin girls. They were eligible for Head Start because of the girls' disabilities, as dad is a College Professor and supports his large family while mom stays home, they weren't 100% income eligible but in need of our program for extra intervention with the twins' disabilities. They have two other children with significant disabilities, and their youngest is slightly delayed as well, so this family has become familiar and very involved with resources within our community to help their children.

The girls entered the program with Global Developmental Delays. They received comprehensive services through our local school district, as well as Speech Services while at Head Start. They would go half a day to Head Start and half a day to a comprehensive preschool class the school district offers as well. They were not speaking, mostly grunting and pointing to communicate. They needed the social exposure as well as the early intervention programs they were receiving. They were also not potty trained. We had a feeling that these girls were going to really flourish in our program, and being involved in numerous other programs to help them, we were very anxious to watch the girls change and grow over the next two years.

Upon exiting our program, these girls really proved to us that early intervention works! They left our program speaking very clearly, in complete sentences, and being able to verbalize needs as they came along, and then even more. Listening to them carry on conversations with their classroom friends was just incredible! They are very smart girls, and now that they are able to communicate significantly better, they really showed off their intelligence. They also exited our program being fully potty trained. They have such cute personalities, it has been an incredible blessing for those of us able to work with them and watch their transitions. They truly flourished in Head Start, and we are thankful that their mother was willing and able to share with us their feelings.

Mom stopped by the Head Start center the other day to discuss the possibility of getting their youngest child in our program as he had recently had slight developmental delays diagnosed. As we were talking, she brought up the girls and how they thought that they were going to need half day Preschool and half day Kindergarten when they go to Kindergarten in the fall, but she said that they were accepted into Full Day Kindergarten! And to this she said, "I attribute that solely to you guys (Head Start) and 409 for working with them and helping them." She also said that she doesn't care if a program doesn't work for 50% of people, even if it works for just 2%, it is still a success. These children and this family is an inspiration, a true gift to have the opportunity to learn and grow with them, and to watch them succeed repeatedly despite everything else they have going on. This amazing success story just proves how wonderful Head Start really is, and how important early intervention programs and community partners really are!

# NEK-CAP Inc. Head Start/Early Head Start Fatherhood Engagement Initiative 2013

With financial assistance from the Kansas Department for Children and Families, NEK-CAP Inc. Head Start was able to offer a series of Strong Dads sessions. To accommodate as many parents as possible over a nine county area, three sessions were offered at four different locations. Eighty-six (86) parents participated in the kick-off event held in March, ninety-eight (98) attended the second session, and fortythree (43) were present at the final session. Incentive funds made a lot of difference, in terms, of participation. Reimbursement for mileage, a hot meal, and child care were appreciated by the dads.

The overall evaluation from parents was extremely positive. Through the evaluations of the Strong Dads Program we have formally heard back from the parents. We want to share a few of those comments that you were instrumental in making a reality for them: "I would say that I have learned to be a better dad all around because I now play more, read to, and interact better with my kids."

"It has helped me strengthen our relationship and has given us extra quality time together."

"I totally enjoyed the experience and understand and appreciate how important it is to be a good dad!"

"I am glad that the program was expanded to allow moms to attend."

"What a neat program for families!"

"I love the toys that we were given, the book was fun to read to my child." "I'm sorry the sessions are over!"
