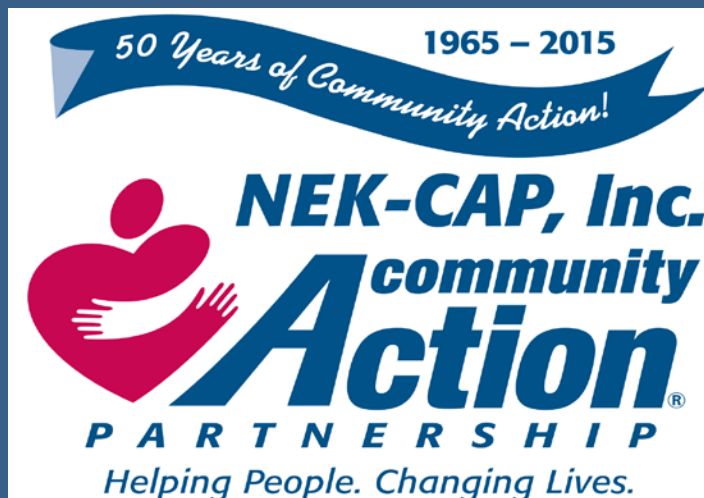

We had planned for the conference in June of 2015 and were excited by the notion of change. We asked Erick Vaughn, Executive Director of Kansas Head Start Association and Clarence Small, Regional Program Manager at the Region VII Office of Head Start in Kansas City, to open and close our meeting respectively. We had some additional awesome sessions on the agenda which included a Parent Panel; They’re Not Just Baby Teeth presented by Kathy Hunt, Dental Project Director at Oral Health Kansas; Child Abuse and Neglect presented by Bev Turner, Education Program Director from the Sunflower House; and Derek Krogh, Regional Manager with Lakeshore Learning Materials.

This was the first year for breakout sessions. Staff could choose what workshop they wanted to attend – they had choices like ERSEA (Eligibility, Recruitment, Selection, Enrollment and Attendance); Bed Bug Guys; Emotional Baggage; Happy and Positive Mealtimes with Family Style Meal Service; Physical Activity; CAP60 101; and ACE (Adverse Childhood Experiences).

During this three-day conference, staff received additional trainings that included: Fire Extinguisher Training, Bus Monitor Training & 3rd Party Check, Active Supervision, Code of Ethics / Confidentiality, In-Kind, and Standards of Conduct presented by agency staff.

Our conference wouldn’t have been complete without exhibitors! We had vendors from Lakeshore Learning Materials, Constructive Playthings, Oral Health Kansas, Books are Fun, KANZA Mental Health, Brooke’s Publishing, John R Green Co, KODO, Teaching Strategies’, Healthy Living Kansas, Early Detection Works, United Health Care, and Amerigroup Kansas, Inc. The vendors were a new attraction and staff truly enjoyed visiting with and learning from each of them.

Of course we can’t forget the Selfie Station for capturing memorable photos from our event. Overall, we enjoyed and learned from the conference. She keeps in contact with me and called to tell me she was able to get all of her outstanding

bills taken care of and that her \$10,000.00 fine that she was paying on was recently wiped out due to her paying her payment every month for the last couple of years, she never missed a payment that was always the first payment she made of the month and the judge forgave the rest of the payments. We had discussed this in a home visit about being able to rid herself of this payment and the good feeling that comes with paying off debt. The other debts that she had are paid in full. She was really happy with herself and I was too. Sometimes when working with people you never really know if they listen to you when discussing budget or money issues but I now know she did.
